FENESTRATION INSTALLATION & SURVEYING SCQF LEVEL 6

This qualification is aimed at those who work as Installers and Surveyors of windows and doors, or conservatories or curtain walling, and is available with 2 pathways to achievement, Installer and Surveyor.

It is not expected that all Installers carry out the same activities, or that Installers and Surveyors carry out the same duties: the optional units are structured to ensure that all those employed in the industry have equal opportunity to achieve the relevant qualification, each pathway has its own group of units in a separate option group, although they both share common units in the mandatory section of the qualification.



This qualification is at Level 3, and should be taken by those who are experienced Installers or Surveyors, capable of dealing with a wide range of problems, including working with installations that have complex requirements. Candidates will often take a technical supervisory role, particularly in relation to less-experienced Installers or Surveyors. They will also work closely with customers and have well-developed customer service skills

FENESTRATION INSTALLATION & SURVEYING SCQF LEVEL 6 - UNITS

To achieve the award you must:

- Complete all Mandatory units as shown, plus the required number of units from the selected pathway.
- Complete Core Skills in Numeracy, ICT and Problem Solving at SCQF Level 5 (if you have not already achieved them).

Fenestration Installation (Pathway 1) Mandatory Units

- Promote and maintain health and safety within the working environment
- Confirm installation instructions
- Diagnose and rectify technical problems
- Assess the quality of materials
- Install windows, doors, conservatories and non-complex curtain walling

Fenestration Surveying (Pathway 2) Mandatory Units

- Promote and maintain health & safety in the installation working environment
- Identify fenestration installation requirements
- Produce specifications for fenestration installations

Optional Group A - All pathways: choose either unit

- Comply with building regulations/standards related to windows, doors and conservatories in the fenestration industry
- Comply with building regulations/standards related to curtain walling in the fenestration industry



Fenestration Installation (Pathway 1) Optional Units (choose any 2 units)

- Remove windows, doors and panels and prepare apertures
- Install complex curtain walling
- Maintain and repair windows, doors and conservatories
- Maintain curtain walling
- Install glass and panels into supporting frames and structures
- Improve the work of the organisation through the use of resources, communication and working relationships
- Control fenestration installation
- Plan resources for use in fenestration installation and surveying

Fenestration Surveying (Pathway 2) Optional Units (choose any 1 unit)

- Plan resources for use in fenestration installation and surveying
- Improve the work of the organisation through the use of resources, communication and working relationships

Fire Resistant Glazing (Pathway 3) Optional Units (choose any 1 unit)

- Use of fire-resistant glazing in timber screens and doors
- Install fire-resistant glazing in metal door and frame systems
- Use of fire-resistant glass in individual systems
